**ULTRA-GOG 300** Safety Goggles meet ANSI Standard Z87.1, OSHA Standard 1910.133 for eye and face protection, and NIOSH recommendation HSM-73-11009 for eye protection against UV from most sources. They fit comfortably over Rx frames. Replacement lenses are available.

**ULTRA-SPEC 100** Safety Spectacles conform to 21 CFR PART 1040 and 1040.20 (C) (5) proposed sunlamp product performance standard for protective eyewear, and also meet NIOSH recommendation HSM-73-11009 for eye protection against UV from most sources. They fit comfortably over Rx frames.

**Full-vision VISORGOGS®** are uniquely designed for use in operating suites and offer enhanced eye protection against glaring overhead lights and short-wave 254 nm UV. VISORGOGS can be worn over Rx frames and, because they're free from struts or frames, they will not obstruct vision. VISORGOGS conform to 21 CFR Part 1040 and 1040.20 (C) (5) proposed sunlamp product performance standard for protective eyewear; and meet NIOSH recommendation HSM 73-11009 for eye protection against UV radiation from most sources, ANSI Z87.1 Standard for Safety Eyewear, and OSHA Standard 1910.133 for eye and face protection.

**ULTRA-SHIELD 200** Face Masks provide added protection for face and neck areas by reducing skin reddening erythema-producing rays. They can be worn in conjunction with ULTRA-GOG 300 safety goggles and ULTRA-SPEC 100 safety spectacles.
